To successfully meet the requirements of the structured credit system, a certified person must earn at least 100 points per period of previous 5 years. This is specified as a certification year and not as a calendar year.

Renewal of certificate validity for levels 1, 2 and 3:

A Level 1 certified person must obtain a minimum of 75 out of 100 points for any combination of activities in Part A.

A Level 2 or 3 certified person must obtain a minimum of 50 out of 100 points for any combination of activities in Part A.

If the certified person does not meet the requirements of the structured credit system, he/she must successfully pass practical exam.

Recertification for level 3:

A Level 3 certified person must obtain a minimum of 50 and a maximum of 70 out of 100 points for any combination of activities in Part A and a minimum of 30 and a maximum of 50 out of 100 points for any combination of activities in Part B.

If the certified person does not meet the requirements of the structured credit system, he/she must pass a written exam.

1	Performance of NDT activities	Performance of a NDT inspection (work of NDT operator)
2	Completion of theoretical training in the method	Participation in an educational activity/training in the NDT method, the extension of which you are requesting, with the aim of increase in the qualification, becoming familiar with changes in legislation, technical standards, procedures, etc.
3	Completion of practical training in the method	Participation in the educational activity/practical training in the NDT method for which you are requesting an extension, in order to improve your practical skills
4	Delivery of practical or theoretical training in NDT in the method considered	The work of a trainer, lecturer (theoretical or practical part) for a given NDT method within a training center
5	Participation in research activities in NDT field or for engineering in NDT	All NDT related activities such as: NDT inspection plan; drafting and verification of NDT procedures; NDT device proposal; evaluation of NDT techniques, mainly as part of expert opinion; coordination of work and supervision of NDT personnel; validation of NDT techniques, etc.

6	Participation to a technical seminar/paper in the field of the method or technique	Participation in a conference, professional seminar with the aim of gaining new knowledge in a given NDT method/technique and becoming familiar with new trends in the field of NDT
7	Presenting a technical seminar/paper in the field of the method or technique	Presentation of a professional article in the field of NDT at a conference, professional seminar
8	Current individual membership in NDT or NDT related society	Valid membership in a given year in SSNDT, in expert commissions/committees of NDT (Slovak or/and international NDT societes)
9	Technical oversight and mentoring of NDT personnel/trainee in the relevant	Supervision or personal training (mentoring) of a NDT worker, other than that in a training center as a trainer, e.g. NDT referee
10	Participation or convenorship in standardization and technical	Valid membership in a given year in technical or standardization committees
11	Performing a technical NDT role within a certification body	Activity within the certification body (examiner, head of examination)

In order to assess all activities (points 2-11), the certified person is obliged to submit documentation or evidence confirming these activities. E.g., confirmation of lecturer activity, participation in a conference, membership, publication activity, etc. is considered as proof. If a certified person requests the extension of more than one certificate, the points allocated for a specific activity can be added to the total of the number of points for each certificate only in activities that are not specific to a particular method (e.g. committee membership)
